**NOTICE TO THE MINOR CHILD'S
NATURAL GUARDIAN**

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF MARANATHA SCHOOL OF DANCE & THE ARTS, ITS OWNERS, DIRECTORS, EMPLOYEES, CONTRACTORS, VOLUNTEERS, REPRESENTATIVES, AND AFFILIATES USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM MARANATHA SCHOOL OF DANCE & THE ARTS, ITS OWNERS, DIRECTORS, EMPLOYEES, CONTRACTORS, VOLUNTEERS, REPRESENTATIVES, AND AFFILIATES IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND MARANATHA SCHOOL OF DANCE & THE ARTS, ITS OWNERS, DIRECTORS, EMPLOYEES, CONTRACTORS, VOLUNTEERS, REPRESENTATIVES, AND AFFILIATES HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

By participating in a trial class or activity at Maranatha School of Dance & the Arts ("Maranatha"), I understand and agree to the following:

CLASS PARTICIPATION

Maranatha reserves the right to cancel, reschedule, combine, or modify classes or provide substitute or replacement instructors as circumstances require.

ASSUMPTION OF RISK & RELEASE OF LIABILITY

I understand that participation in dance, theater, music, physical activity, and related studio activities involves inherent risks. For purposes of this agreement, "inherent risk" means dangers or conditions, known or unknown, that are characteristic of, intrinsic to, or an integral part of the activity and that are not eliminated even if the activity provider acts with due care in a reasonably prudent manner.

Inherent risks include, but are not limited to, physical injury, illness, falls, collisions, strains, sprains, fractures, communicable diseases, permanent disability, property damage, or death. For a minor participant, inherent risks also include the failure of the activity provider to warn the natural guardian or minor child of an inherent risk and the risk that the minor child or another participant may act negligently or intentionally and contribute to the injury or death of the minor child. For purposes of this provision, "participant" does not include Maranatha School of Dance & the Arts or its owners, affiliates, employees, or agents.

I knowingly and voluntarily assume the inherent risks associated with participation for myself and/or my child.

I hereby release, waive, discharge, and hold harmless Maranatha School of Dance & the Arts, its owners, directors, employees, contractors, volunteers, representatives, and affiliates from claims, liabilities, demands, damages, costs, or expenses arising out of or related to inherent risks of participation in Maranatha activities, to the fullest extent permitted by Florida law.

I agree to indemnify and hold harmless Maranatha School of Dance & the Arts from third-party claims arising from the actions or conduct of myself or the participating child.

HEALTH & EMERGENCY CARE

I understand that participation in studio activities may involve exposure to communicable illnesses and voluntarily assume the risks associated with such exposure.

I agree that neither I nor my child will attend Maranatha activities while exhibiting symptoms of a contagious illness. Participants should remain home while feverish or vomiting and until they have been fever-free and free from vomiting for at least 24 hours without the use of fever-reducing medication.

I agree to notify the studio of any medical conditions, allergies, injuries, or other concerns relevant to the participant's safe participation. If a parent or guardian cannot be reached immediately in an emergency, I authorize Maranatha and its representatives to obtain emergency medical treatment for the participant. I understand that I am financially responsible for any resulting medical expenses.

PHOTO, VIDEO & MEDIA RELEASE

I grant Maranatha School of Dance & the Arts permission to photograph, record, or otherwise capture the image, voice, likeness, and performance of myself and/or my child while participating in Maranatha activities and to use such materials for promotional, educational, archival, advertising, social media, website, and other lawful studio purposes without compensation.

I understand that participants and families may not record, reproduce, distribute, post, livestream, or publicly share classes, choreography, music edits, recordings, or other studio materials without prior permission from Maranatha.

CONDUCT & VISITOR POLICY

Students, parents, and guests are expected to behave in a safe and respectful manner. Disruptive, disrespectful, unsafe, or inappropriate behavior may result in removal

or dismissal from classes or events at the discretion of studio leadership.

To help maintain a safe and welcoming environment:

- Parents and guests should not enter classrooms unless invited by a teacher or staff member.
- Maranatha is a 100% smoke-free property. Smoking and vaping are not permitted anywhere on site.
- Pets are not permitted on the premises. Service animals are permitted in accordance with applicable law.
- Children who are not actively in class must be supervised by an adult at all times.
- Please keep noise to a minimum in common areas while classes or rehearsals are in session.
- Photography or video recording of students in class is not permitted without prior permission.
- Outside promotions, flyers, solicitation, or sales are not permitted without approval from studio staff.
- Please use designated parking areas and drive slowly and cautiously, as children may be present.
- To avoid overcrowding, families are asked to limit the number of guests accompanying each dancer whenever possible.
- Maranatha is not responsible for lost, stolen, or damaged personal property.

ACKNOWLEDGMENT

This agreement is governed by the laws of the State of Florida. If any provision is found invalid or unenforceable, the remaining provisions shall remain in full force and effect. If the participant is under 18 years of age, the person accepting this agreement represents and certifies that he or she is the minor child's parent/natural guardian and has authority under Florida law to execute this agreement on the minor child's behalf. I acknowledge that I have received or will obtain access to applicable Maranatha School of Dance & the Arts policies and agree to follow all applicable policies, procedures, rules, and guidelines.
